In addition to the grant from the DHST, the ICHM also receives grants from elsewhere currently totalling 5000 Euros annually. This is used both for early career scholars (topping up the DHST grant) and for established scholars. Hence our annual income last year was 6500 Euros (see Financial Report).

Joint Mathematics Meeting (Boston, 4-7 January 2023)

Co-sponsorship of the Special Session on the History of Mathematics but with no financial implication. This meeting, which has international participation, provides the ICHM with a good opportunity to promote its activities, especially to early career scholars.

BSHM Research in Progress (University of Oxford, 25 February 2023)

This meeting is for PhD students and early career scholars. We anticipate a funding application of approximately 500 EUR to assist participants with travel costs.

DMV History of Mathematics (Naunhof, 15-19 March 2023)

This biennial meeting usually attracts about 50 scholars and the ICHM has agreed to co-sponsorship up to 1000 EUR to assist early career scholars and independent scholars with registration fees.




