mathematics initiatives, e.g. panel discussions at international mathematics conferences such as the European Congress of Mathematics. We have recently agreed to give support to a series of online events being organised by the International Academy for History of Science and the Institute for Advanced Study, Princeton.

Future plans

Joint Mathematics Meeting (San Francisco, 3-6 January 2023)

Co-sponsorship of the Special Session on the History of Mathematics but with no financial implication. This meeting, which has international participation, provides the ICHM with a good opportunity to promote its activities, especially to early career scholars.

BSHM Research in Progress (University of Oxford, 2 March 2024)

This meeting is for PhD students and early career scholars. We anticipate a funding application of approximately 500 EUR to assist participants with travel costs.

34th Novembertagung (University of Belgrade, November 2024)

The

Novembertagung, which is organised by early career scholars for early career scholars, is held every year in a different country. We consider this to be one of the most important meetings supported by the ICHM as it enables early career scholars to make contact with one another at an international level as well as having the opportunity to present their work in a supportive environment. We anticipate a funding request of c.2000-2500 EUR.

We expect a number of early career scholars to apply to the ICHM for travel funding to attend this programme (funding for accommodation etc. is provided by the INI).

New Zealand ICHST 2025
