The Novembertagung, which is organised by early career scholars for early career scholars, is held every year in a different country. We consider this to be one of the most important meetings supported by the ICHM as it enables early career scholars to make contact with one another at an international level as well as having the opportunity to present their work in a supportive environment.

Due to Covid-19, many early career scholars have been denied the opportunity to participate in face-to-face conferences, and helping with funding their attendance at such conferences is usually the main way in which the ICHM offers them support. At the online Novembertagung 2020, we announced to early career scholars the availability of ICHM funding for support in different ways, such as registration fees for online conferences, , childcare grants for attendance at online conferences, cost of scans from overseas archives, etc.
