ICHM organised a *History of Mathematics Symposium* at the 2018 International Congress of Mathematicians (ICM, Rio de Janeiro, Brazil, August 23-29, 2018). Four lectures, including the *Montucla Prize Lecture*, were given.

ICHM Co-sponsored the conference *Mathematical Communities in Postwar Reconstruction (1918-1928)* (CIRM, France, November 12-17, 2018).

The Grattan-Guinness Archival Research Travel Grant. The ICHM actively promoted this grant.

Historia Mathematica is the official journal of the ICHM. It appears four times annually and publishes roughly 525 pages of original research in the history of mathematics from all times and cultures. The journal is currently edited by Nathan Sidoli (Waseda University, Japan) and Reinhard Siegmund-Schultze (University of Adger, Norway). It is published by Elsevier Science and is available electronically to subscribers of ScienceDirect.

c. Please list any other activities supported in the last year e.g. prizes, e-lists etc.

The ICHM maintains an international e-mail list. This list serves to send out information from the ICHM to historians of mathematics internationally. Any historian of mathematics may become part of this e-list simply by contacting the Secretary of the ICHM.

3. Future plans

€2,500 will be made available to the organizers of the 2018 Novembertagung (Seville, Spain, November 28-30, 2018). This is an international conference for doctoral students and young scholars. Funds will be used to support the travel and subsistence of participants.

ICHM Co-Sponsored AMS-MAA Special Sessions on History of Mathematics (Baltimore, Maryland, USA, January 10-12, 2019). No financial aid requested.

As is customary, funds that are not used will be returned to the Treasurer.

b. Please outline any plans for development of the Commission's website.

During 2017 the ICHM website was remodelled with the assistance of website specialists from the International Mathematical Union. Since the beginning of 2018 it has been part of the IMU website and costs are covered by the IMU.

c. Please outline any planned changes to the governance or organisation structure of the Commission.

The ICHM rules of governance were reformulated in 2017 as "terms of reference" for inter-union member commissions of the DHST and the IMU. There are no plans for any further changes.

4. Financial report

a. Please provide a breakdown of the use of DHST funds in the previous year in the 3 categories of website, administration costs and conference support. Receipts for expenditure should be scanned and included with your report for possible financial audit by DHST.

Total expenditures for the past year (including expenditure from both DHST funds and from other funds) are administration (\$52) and conference support (\$8586). Conference organizers submit reports on their conferences that are published on the ICHM website. The financial assistance is offered to the conference organizer in the form of a grant. Although a summary of how the funds are used is required, the ICHM does not currently employ detailed accounting procedures involving scans of receipts.

Early career scholars receiving support from DHST and from other funds: €700 to the organisers of the Novembertagung to support travel costs of the participants (all of whom were doctoral students or recent post-graduates).

US\$2,210 to support Jemma Lorenat (Pitzer College, USA) to receive the Montucla Prize and deliver the Montucla lecture at the ICM 2018 (Rio de Janeiro).

€2,000 to support accommodation costs for four early career scholars at the conference *Mathematical Communities in Postwar Reconstruction (1918-1928)* (CIRM, France).

We are budgeting for \$75 (administrative costs) and US\$1,500 (conference support). The conference funds will contribute support to the 2018 Novembertagung in Seville.

The financial position of the ICHM is currently good. We receive funds each year from Elsevier for our oversight of the journal *Historia Mathematica*, the official journal of the ICHM.
