Please submit via email each nominee's name, accompanied by a two-page CV, by November 15, 2005. The nomination must include a statement indicating that each nominee is willing to serve if elected. The delegates to the 15th General Assembly of IMU will also choose the composition of the next Executive Committee (EC) of the International Commission on Mathematical Instruction (ICMI). If proposed changes to the process of election of the EC of ICMI are approved by the 2006 IMU General Assembly, this EC will exceptionally serve for only three years (2007-2009) instead of for four years, so as to facilitate the transition to a new system whereby the EC of ICMI would be elected by the General Assembly of ICMI (rather than that of IMU), with a slate proposed by an ICMI Nominating Committee, whose composition would include representation of both the IMU and ICMI communities. The proposed changes are the result of lengthy discussions between the EC's of IMU and of ICMI. However the election of the next ICMI EC remains the responsibility of the IMU General Assembly. (See the documents accompanying the IMU Circular #3/2004, Oct. 29, 2004, for further details on the proposed transition process.)

The ICMI Nominating Committee, acting also in an advisory role to the IMU EC, is thus asking that the Committee for Mathematics nominate one or more candidates to be considered to serve on the ICMI EC. Please submit via email each nominee's name, accompanied by a two-page CV, by November 15, 2005. The nomination must include a statement indicating that each nominee is willing to serve if elected. Please send the nominations to the IMU at imu@ias.edu.
